Engagement of Lady Medical Doctor (Part - Time) on Contract Basis

National Institute of Food Technology, Entrepreneurship and Management-Thanjavur (NIFTEM-T), under Ministry of Food Processing Industries, Thanjavur intends to engage Lady Doctor (Part - Time) on contract basis at NIFTEM-Thanjavur. **The last date for receipt of application is 21 days from the date of publication in the Daily News Paper.**

A. Details of the Post, Essential qualifications and Remuneration is given below:

B. Eligibility Criteria and terms and conditions of engagement of Lady Medical Doctor(Part-time) on contract basis

NIFTEM-Thanjavur invites applications for engaging the services of Lady Medical doctor(Part-time) on contract basis with fixed remuneration as per number of visits on the following terms and conditions.

1. Applicant should be a medical graduate (MBBS) of any recognized University in the allopathic system of medicine and should, in addition, possess at least 2 years' experience in any hospital or as Medical Practitioner.
2. Candidates with previous hospital experience (at least 2 years) will be given preference.
3. The Lady Medical doctor will be paid the remuneration at a fixed rate of Rs.1,300/-per visit of two hours and the number of visits in a week is three (12 visits in a month). The fixed remuneration is payable on monthly basis. The remuneration shall be reducing proportionately if the number of visits are less than what is prescribed.

4. The candidates should submit applications in the prescribed format. The application should be sent in a cover super scribed “Application for the post of Lady Medical Doctor (Part-time) on contract basis to the Director, NIFTEM-Thanjavur and it should not entertain any correspondence with the candidates who are found ineligible / not considered eligible for interviews.
5. The services rendered by the Lady Medical Doctor will not confer any right on them for any temporary or permanent post in the NIFTEM-Thanjavur.
6. The NIFTEM-Thanjavur reserves the right to terminate the contract of Lady Medical Doctor during the period of contact, on one month notice on either side or one month remuneration in lieu thereof or in case a Lady Medical Doctor commits a breach of the NIFTEM-Thanjavur or the terms and conditions of the contract accepted by him/her, displays negligence, inefficiency or indolence, or knowingly does anything detrimental to the interests of the NIFTEM-Thanjavur or in conflict with its instructions or is guilty of any other act of misconduct.

Note:

- i. The candidate must possess the essential prescribed qualifications as well as a valid registration with the concerned statutory authority (wherever applicable) on or before the last day of receipt of application. Experience is desirable. (preferably 2 years)
- ii. Nomenclature of qualifications shall be as prescribed by UGC/Medical Council of India.

C. How to Apply

- i. Candidates have to submit the filled-in application form along with other relevant documents to the Director, NIFTEM-Thanjavur.
- ii. The following relevant documents are required to be sent along with the filled- in application to The Director, NIFTEM-Thanjavur.
 - a) Educational qualification documents i.e., SSLC, MBBS certificates,
 - b) MD/MS Certificates (if applicable)
 - c) Medical Council of India/State Council Registration certificate,
 - d) Identity proof, Address Proof,
 - e) No Objection Certificate (NOC) from existing employer, if any (in case of Govt. /PSU employees) and
 - f) Experience certificate, if any, in pdf format only.
- iii. All communications with the candidate shall be through email/sms. If required, NIFTEM-Thanjavur may seek additional / other documents after this date also.
- iv. The shortlisted candidates will also be informed through e-mail and SMS about the date& time of interview.

- v. The electronic mode of interview Webex will be intimated to the candidates in advancedue to rapid spread of covid 19. However, the candidates are advised to be prepared to give interview in all the medium mentioned here, and to appear in person, if requiredby NIFTEM-Thanjavur.
- vi. Candidates may please ensure that they are fulfilling all the requisite criteria to apply for the above post, failing which, their candidature is liable to be rejected/cancelled.
