


STEPS FOR IIFPT'S ONLINE TRAINING ON SENSORY SCIENCE AND FOOD EVALUATION REGISTRATION

Step 1: Open SBI Collect in your browser. Link:

Accept the terms and conditions and click **“Proceed”**


