Sub: Vacancy circular for the post of Consultant (Financial) on a contractual basis in the National Institute of Food Technology Entrepreneurship and Management - Thanjavur(NIFTEM-T), Thanjavur, MoFPI, GoI.

National Institute of Food Technology Entrepreneurship and Management-Thanjavur (NIFTEM-T), Thanjavur – 613 005 under Ministry of Food Processing Industries, GoI invites applications for engaging “**Consultant (Financial)**” on a Contractual basis.

Engagement of Retired Officers as “Consultant (Financial)” on a Contractual Basis (01)

The National Institute of Food Technology Entrepreneurship and Management-Thanjavur (NIFTEM-T) invites applications from interested and eligible retired officers to serve as “**Consultant (Financial)**” at NIFTEM-T on a contractual basis for a period of one year initially that may be extended, as per DoP&T Orders passed in this regard from time to time.

Eligibility conditions: -

He/She should be a retired Assistant Accounts Officer/Section Officer (Accounts/Audit) or equivalent grade officer from Central Govt. Depts./PSU/Central Autonomous Bodies with Grade pay of Rs.4600/- / Rs.4800/- or equivalent at Pay level not lower than 7 / 8 as per VIIth CPC. He/She should possess a Degree from a recognized University / Institution and should have proficiency in matters such as audit, accounts, administrative rules and regulations processing of Tenders, procurement including GEM, GFR, FR & SR etc.

Age Limit: -

The candidate should be below 65 years of age with good health.

Fixed Remuneration and Transport Allowance:

a. Old Pension Scheme Candidates:

The candidate selected for engagement will be given a consolidated remuneration of the “last pay drawn” minus the amount of pension being drawn.

b. New Pension Scheme Candidates:

The consolidated remuneration of an amount equivalent to 30% of the last basic pay as drawn at the time of retirement shall be deducted from the last basic pay and the resultant amount shall be fixed monthly remuneration for candidates retired under NPS.

c. Transport Allowance:

Transport Allowance shall be provided to the consultant based on the transport allowance drawn by him at the time of his superannuation. No other allowance shall be admissible to the consultant.

The terms and conditions of the engagement are mentioned in Annexure II.

How to Apply: -

Application as in Appendix I & II may be downloaded from the NIFTEM-T website duly filled and sent along with relevant documents/certificates (xerox copies) to **The Registrar, National Institute of Food Technology Entrepreneurship and Management -Thanjavur (NIFTEM-T), Pudukkottai Road, Thanjavur - 613 005 within 30 days from the date of publication in official website of NIFTEM-T.**

Annexure-II

Terms and Conditions for Consultant (Financial) on a Contractual Basis

1. Initial engagement as a Consultant will be for a period of one year on a contract basis in the NIFTEM -T.
2. Consultant shall work “full time basis” at NIFTEM-T initially for a period of one year. After expiry of initial term, engagement may be extended, based on requirement of the Institute and performance of Consultant after the approval of ‘competent authority’. The contract period may be curtailed subject to review, at the sole discretion of this Institute. The engagement of a consultant is of a temporary (non-official) nature and as per the DoP&T OM dated 09.12.2020.
3. The work and conduct of the retired officers shall be reviewed by the Director, NIFTEM-T from time to time. In case, his/her performance is not found satisfactory, his/her engagement is liable to be terminated without assigning any reason.
4. The consultant needs to give a minimum of one month prior notice in case he/she wish to terminate the contract.
5. The Institute shall also reserve the right to terminate the services of Consultant at any time without giving any prior notice and also without assigning any reason. The engagement of consultant will not confer any right on the part of individual for claiming permanent appointment to the post for which he/she has been engaged as a consultant.
6. Consultant will not be entitled for any benefit / compensation/ absorption / regularization of service in this Institute / Ministry.
7. The consultant shall not divulge any information, gathered by them during the period of their assignment to anyone who is not authorized to know/have the same.
8. Leave entitlement will be as per, DoP&T OM dated 09.12.2020 passed in this regard from time to time.
9. Allowances: Consultants shall not be entitled to any kind of allowance or accommodation facility. However, should they be required to travel inside the country in connection with the official work of the Ministry, TA/DA as admissible to a regular employee of the same grade will be paid to him/her after obtaining approval of the competent authority.
10. No TA/DA shall be admissible to the Consultants for attending the interview or for taking up the appointment as the Consultant. Further, consultant will not be allowed any foreign travel at government expenses.
11. The engagement as Consultant shall not be considered as a case of re-employment.

12. The Consultants may be called to the office on Saturdays, Sundays and other Gazetted holidays or may be asked to sit late in the office after office hours, in case of exigency of work. No extra allowances will be permissible for the same.
13. If any declaration given or information furnished by the candidate proves to be false or if the candidate is found to have willfully suppressed any material information, he/she will be liable for termination from engagement service as consultant and also such other action as Government may deem necessary.
